

## Human Research Protection Program Undergoes Reaccreditation

The Ohio State University is seeking reaccreditation of its Human Research Protection Program (HRPP) through the Association for the Accreditation of Human Research Protection Programs (AAHRPP). A team of experts were on site November 27 – 29, 2012 to complete the final step in the AAHRPP reaccreditation process. The site visit included record reviews and interviews with approximately 125 individuals involved in human subjects research at Ohio State.

Accreditation indicates Ohio State's commitment to scientifically and ethically sound research and to continuous quality improvement of the human research protection program in accordance with all applicable requirements governing research involving humans. Ohio State's human research protection program initially received full accreditation in March 2010. Over 200 national and international organizations have received AAHRPP accreditation to date.
